## SURFACE PREPARATION

For the best results, remove as much mould, algae or fungi as possible by scraping and brushing, before treating. **Dulux Trade Weathershield** Fungicidal Wash will only be effective on surface growths. Where old growths have been trapped between previous coats, all existing coatings need to be removed. Special precautions should be taken during surface preparation of pre-1960s paint surfaces over wood and metal as they may contain harmful lead.

## SYSTEMS INFORMATION

SHAKE THOROUGHLY BEFORE USE. Apply by brush or low pressure (non-atomising) spray to all affected areas. Leave until dry (minimum 1 hour), then remove any dead growth with brush or by washing the treated area; failure to do this may result in discolouration of subsequently applied coatings. Repeat the process if necessary. On badly affected areas the use of high pressure water-hosing may be necessary to remove all organic growth completely. Do not apply in wet weather.
